General Instructions

Each permit form must be completed in full and signed.

Please print information LEGIBLY AND COMPLETELY to ensure validity.

1. **Permit must be dated, complete and legible. Print please.**
2. **Fill in Name, Mailing Address** (Street Name, Number, PO Box, City, and Postal Code) **and Email address.** The Name and address is used for regulatory and insurance purposes and the SANS Sno' Trails Magazine mailing. if it is illegible, the permit is not valid, and the buyer will not receive the magazine.
3. Check appropriate SNO'TRAILS Info boxes. If mail or email, ensure the address is legible.
4. Fill in Club Name and Vendor Name.
5. Check the appropriate trail permit type.
6. Each buyer's signature is proof of their agreement to the conditions of sale and the 'Know Before You Go!' statements on the trail permit.

Lost or damaged permits may only be replaced by the original vendor/club for \$10/permit.

1. Ensure purchaser has proof of two previously purchased full priced permits, either "Early Bird" or "Full Season" qualify. **"Classic" permits DO NOT qualify.**

2. Ensure all snowmobiles are "REGISTERED" at the same address to qualify.

Note: It is important that all snowmobiles are registered to the same address and all should be sequentially numbered unless purchased on different dates. Please reference permit numbers used, to qualify for "Family" Permit. Print all qualifying permit numbers on each permit.

Classic \$100.00

(Until December 15th, ONLY!)


Definition: **Registered snowmobile must be 15 years old or older from the current season.**

To qualify for a 'Classic' permit **a current snowmobile registration proof must be copied and attached to the SANS copy** for each machine at time of purchase.

The **name and address on the registration must match** the name and address of the person purchasing the permit, no exceptions. If they do not match they cannot purchase a classic permit.

A copy of **the valid snowmobile registration must be attached** to the SANS white slip at time of purchase.

Note: Missing registration documents and mismatched names and addresses will result in additional fees charged to the applicable club.


